

Win Ruby Tuesday For A Year Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ELIGIBILITY: Only legal residents of the fifty (50) United States, D.C., and Puerto Rico 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Ruby Tuesday, Inc. ("Sponsor"), or any of its parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). Void where prohibited.

SWEEPSTAKES PERIOD: The sweepstakes (the "**Sweepstakes**") consists of 683 separate drawings and begins on February 1, 2016 at 12:00:00 a.m. Eastern Time ("ET") and ends on February 14, 2016 at 11:59:59 p.m. Central Time ("CT") (the "**Sweepstakes Period**"). The Sponsor's database computer is the official time-keeping device for this Sweepstakes.

HOW TO ENTER: To enter the Sweepstakes, navigate to RubyTuesday.com and click on the link for the Sweepstakes which will take you to the Sweepstakes entry form ("Entry Form") or navigate directly to the Sweepstakes microsite at <http://pages.rubytuesdayrestaurants.com/2016FreeRTforYear/> (RubyTuesday.com and the sweepstakes microsite collectively, "Website"). You must complete all information required in the Entry Form, including name, address, email address, zip code, Designation of one (1) of the 682 participating Ruby Tuesday restaurants ("Participating Restaurant") from the provided list as your local restaurant for purposes of the Sweepstakes ("Designated Restaurant"), and agree to these Official Rules to receive an entry ("Entry"). You must also agree to receive marketing and promotional emails from Ruby Tuesday, but you may unsubscribe from these emails at any time using the unsubscribe link in the message. If all information required in the Entry Form is not completed, you will not receive an Entry. If you enter the Sweepstakes more than once and select different Participating Restaurant as your Designated Restaurant each time, all Entries submitted by you will be associated with the first Designated Restaurant you selected for purposes of entry in a Local Drawing. When completing the Entry form, you will be asked if you have recently dined at a Ruby Tuesday restaurant during the Sweepstakes Period (an "Eligible Visit"). If you have made an Eligible Visit, you can enter the receipt number, date of the visit, and Participating Restaurant and you will receive five (5) additional Entries into the Sweepstakes ("Additional Entries"). Each Eligible Visit will only result in one set of Additional Entries and cannot be re-entered to gain further Additional Entries. Eligible Visits can be at any Ruby Tuesday Restaurant -- they do not have to be at the Designated Restaurant. If you have not made an Eligible Visit or do not have necessary receipt information, you may gain Additional Entries by resubmitting the Entry Form five (5) additional times. Each Entry consists of one chance to win the grand prize ("Grand Prize Drawing") and one chance to win the drawing associated with the Designated Restaurant you selected in your first Entry ("Local Drawing"). **LIMIT TWENTY ONE (21) ENTRIES PER PERSON PER E-MAIL ADDRESS REGARDLESS OF METHOD OF ENTRY.** By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these Official Rules and all decisions of the judges, which shall be final and binding in all respects. All entries must be received by the end of the Sweepstakes Period. Any information submitted by you will be subject to Sponsor's privacy policy posted at www.rubytuesday.com/privacy. Entries found to be in excess of this limit will be disqualified. Any attempt by a person to enter more than the allowed number of entries may result in disqualification. Use of any macro, bot, script or other automated means to submit entries is prohibited.

WINNER SELECTION AND NOTIFICATION: One (1) winner of the Grand Prize Drawing will be randomly selected on or about February 15, 2016 from among all eligible Entries received during the Sweepstakes Period. One (1) winner of each Local Drawing will be randomly selected on or about February 15, 2016 from among all eligible Entries associated with that Participating Restaurant received during the Sweepstakes Period. Potential winners will be notified by mail and/or email using the contact information given at the time of entry on or about February 22, 2016. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within 5 days after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected. Potential winners are subject to verification, including verification of age. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such

potential winner will be disqualified and an alternate winner may be selected. Sponsor is not responsible for any change of email address, mailing address and/or telephone number of entrants.

PRIZES/ODDS: The verified winner of the Grand Prize Drawing will receive *Free Ruby Tuesday for a Year* consisting of twelve (12) \$100 Ruby Tuesday e-gift cards sent electronically monthly, which is the equivalent of one (1) meal for (1) person per week excluding taxes and subject to regional price variations. The e-gift cards will be emailed to the verified winner by the 5th of each month for a duration of twelve (12) months. The verified winners of each Local Drawing will receive a \$50 Ruby Tuesday e-gift card. Prizes are non-transferable, and no cash alternative or prize substitutions will be allowed, except in Sponsor's discretion. A substitute of comparable or greater value may be awarded if prize becomes unavailable for any reason. Odds of winning depend on the number of eligible Entries received.
